Chairman Lyndon Lowe called the HCTDA Budget Forum to order at 9:00am and introduced our two new board members, Jon Feichter with the Town of Waynesville replacing Amie Owens and Mike Huber with Lake Junaluska Conference & Retreat Center replacing Rob Huckaby. Chairman Lowe welcomed them to the board and asked each of them to tell the board about themselves.

Finance Committee Report

- Finance Committee Chairman Chris Corbin reviewed the 3% report informing the board that July is the largest collection month we have had. July was 91% over budget and 13% year over year.
- Chris reviewed the 1% report and stated that collections are up across the board except for Lake Junaluska and that is because there just isn't any group business right now like we do in a normal year.
- On the 4% report you can see that the number of accounts are down 6% but that is due to so many owners are going exclusively with VRBO and Air B&B. The category report shows that vacation rentals are dominating right now with just under 60%.
- On the new Gross Sales Report, you can see that the largest percentage of growth year over year was in Waynesville with 24% growth. Ben Wilder reviewed the 5-year history of gross sales stating that in 16-17 sales were just under 5 million and in 20-21 we are right at 6 million.
- Finance Chairman Corbin informed that the Penalty report is relative short this month with no big changes. He then reported that the Finance Committee had approved two penalty waiver requests. One for Creekwood Village Resort in the amount of \$107.37 and the other for Buffalo Creek Vacations in the amount of \$238.73.

STR & AirDNA Reports

- P. Shaw presented the STR and the AirDNA reports and pointed out that Vacation Rentals are the largest percentage of the market and RevPAR is close to a 40% increase over the past year. This makes up for the hotel/motel shortfall. He went on to state that it will be interesting to see if this trend holds into next year.
- Mr. Shah then went on to ask if and when the municipalities and the county would start regulating the vacation rental business.
- Mike Eveland stated that as some point, regulating the vacation rentals will have to be looked at and that the TDA can help with identifying all of the rentals in the county and moving on from there.
- Director Collins informed the board that she and Ben have been talking with two different Compliance Companies and would be bringing a recommendation to the Finance Committee and then to the board for the next meeting.

New Business

- Chairman Lowe informed the board that we have to do a budget amendment for the increased revenue and asked Director Collins to review with the board the budget amendment
- Chairman Lowe requested approval of the budget amendment in the amount of \$271,275.
- Mike Huber made a motion to accept the budget amendment as presented.
- Chris Corbin seconded the motion.
- Motion passed unanimously.
- Director Collins asked Marketing Manager Ashley Rice to report on a recent award, the materials left at each board members seat, the 2021 Visitor Guide and the Backpacker Video project.
- Director Collins informed the board that the second round of grant funding is now open to accept applications. The deadline is October 28th and the board will be voting on the grant awards at the December 2nd meeting.






GROSS ROOM NIGHT SALES BREAKDOWN





GROSS ROOM NIGHT SALES YTD BREAKDOWN





Grants Awarded to HCTDA

The HCTDA has been awarded two grants this fall. We are requesting approval to accept the grant awards as follows:

Deer Park Sustainability Grant – This grant award is in conjunction with Deer Park, the Blue Ridge Parkway Association and the American Park Network. Applicants had to be a member of the Blue Ridge Parkway Association. Deer Park awarded three (3) grants, each in the amount of \$2,500.

The TDA submitted an application in conjunction with Haywood Waterways as a partner. The application was for a Haywood County Water Conservation Project to implement two water conservation and sustainability measures in the Pigeon River Watershed. \$2,000 of the award money will be used to purchase native trees and shrubs suitable for streamside habitats. The remaining \$500 would be used to print and distribute drink coasters imprinted with "Love Your Watershed." The drink coasters would list actions individuals can take for water conservation, such as picking up pet waste and turning off the faucet when brushing teeth.

Additional matching funds from other partners would be applied to this project. It is anticipated the project would be completed by April 2021.

North Carolina Tourism Recovery Grant – This grant is through the Economic Development Partnership (EDPNC) under the NC Department of Commerce and is in the amount of \$21,500. The funds serve as reimbursement for expenses incurred by the HCTDA for the Recovery Campaign. HCTDA submitted a detailed application of expenses totaling \$33,841.55 and was awarded \$21,500 towards those identified expenses. We have to provide receipts, examples of incurred expenses and a detailed narrative of our recovery campaign.
