MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING ("MOU"), between the Town of Canton, a municipal corporation (the "Town"), and Haywood County, North Carolina, a body politic and corporate and a subdivision of the State of North Carolina (the "County") the Haywood County Tourism Development Authority, a North Carolina Public Authority (the "HCTDA") for the funding of the study of the Pigeon River for recreational access and a community asset for both visitors and residents:

- 1. <u>Pigeon River:</u> With the closure of the Pactiv Mill in the summer of 2023 and the improvement of the river quality downstream from Canton, this study will assess and design potential access points along the Pigeon River to reintroduce the river as a recreational, economic and a cultural identity for the community.
- 2. HCTDA: The HCTDA is currently conducting a Tourism Master Plan and Destination Branding for Haywood County with DCI, Tourism Impact Services, Nichols Tourism Group, Destination Consultancy Group and Alta who are experienced in strategic planning, economic development, and environmental stewardship.

The HCTDA, through their consultants, has offered to prepare a Pigeon River Access Study for both public owned lands and other sites to offer outdoor recreational opportunities along the Pigeon River. The study will provide estimated cost and conceptual renderings to enhance recreational utilization in the amount of \$40,000.

- 3. <u>Responsibility of the County</u>: The County will pay for costs not to exceed \$19,900 of the total cost as outlined in Exhibit "A" Pigeon River Access Study.
- 4. Responsibility of the Town: The Town will pay for costs \$10,000 of the total cost as outlined in Exhibit "A" Pigeon River Access Study.
- 5. Responsibility of the HCTDA: The HCTDA will provide oversight and management of the consultants and pay for cost in the amount of \$10,100 outlined in Exhibit "A" Pigeon River Access Study.
- 6. <u>Assignment</u>: This MOU may not be assigned by either party to fulfill its obligations without the written consent of the other parties.
- 7. <u>Administration for the Memorandum of Understanding</u>: The persons named below shall be administrators for the respective parties and shall be the contact person(s) for matters relating to the administration of this MOU. Either party may change its administrator, address, or telephone number by written notice to the other party.
